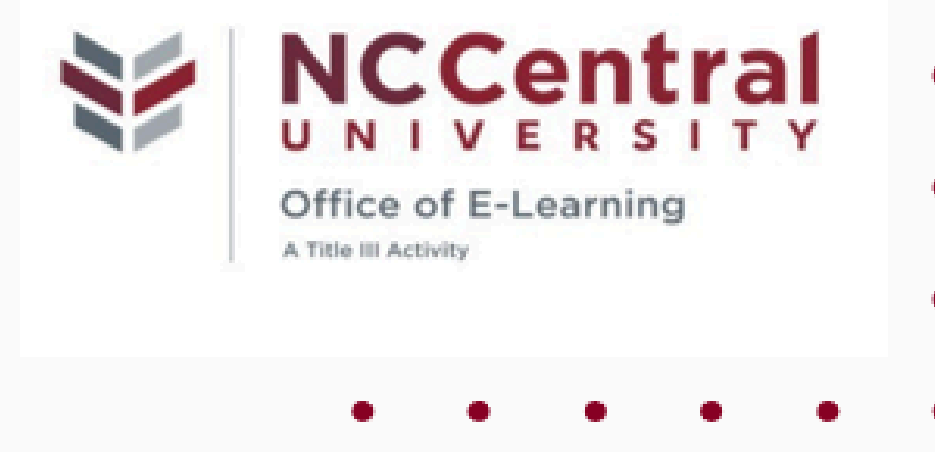

QM SRS	SRS Description

SRS 2.2	The module/unit-level learning objectives describe outcomes that are measurable and consistent with the course-level objectives.
SRS 2.4	The relationship between learning objectives, and assessments is made clear. (Example: Course Map/Mapping Matrix)
SRS 2.5	The learning objectives are suited to and reflect the level of the course.
